## 1. INTRODUCTION

The Mass Rapid Transit Authority (hereinafter referred to as "MRTA"), Ministry of Transport, the Kingdom of Thailand is Implementing the MRT Purple Line Project, Tao Pun – Rat Burana (Kanchanapisek Road) Section (hereinafter referred to as "the Project") as part of Thailand's government policy to develop a complete mass electric train system network to improve quality of life of people in Bangkok and the vicinity in alleviating traffic congestion, improvement of environmental conditions, the reduction of fuel energy consumption. The government had arranged the source of funds for the constructions of the civil works through the domestic loan and private investment, by the Public and Private Partnership (PPP), will be sought for the railway systems.

# 2. THE MRT PURPLE LINE PROJECT

The Project has a total length of approximate 23.49 km. with 10 underground stations and 7 elevated stations. The route is elevated continuing from the existing Purple Line (Tao Pun – Bang Yai Section) alignment at Tao Pun Interchange Station running along the new road of Bangkok Metropolitan Administration (BMA), the viaduct then declines to underground at Kiak Kai. The tunnel runs beneath Sam Sen Road to Bang Khun Phrom then turn left to Phan fa. The alignment intersects with the Blue Line Extension at Sam Yot Station in Sam Yot Sub-district. The tunnel will go underneath Chao Phraya River at Phra Pokklao Bridge and move along Pracha Thipok Road, then passes under Wong Wian Yai to Mahai Sawan Intersection, then transform to Elevated Alignment at Chom Thong. The elevated viaduct pass Pracha Uthit Intersection, crosses Chalerm Maha Nakorn Expressway enters to Rat Burana. The Project include construction of one Stabiling Yard and Four Park & Ride Facilities.

## 3. SCOPE OF WORKS

MRTA is inviting Tenders for the following contracts under this Project:

# Contract 1: Underground Civil Works (Tao Pun - National Library Section)

Design and Construction of both underground and elevated structure starting from Tao Pun Interchange Station and end at the outer edge of National Library Underground Station. This Purple Line Section consists of viaduct, transition structure, cut and cover tunnel, bored tunnels, approximate 4.87 kilometers (km.) in length; approximate 25 to 30 meters under existing ground and the construction of 3 underground stations. Architectural works and Building Services within the stations together with other works. All more particularly described in the Employer's Requirements – Functional.





# Contract 2: Underground Civil Works (National Library - Phan Fa Section)

Design and Construction of underground structure starting from National Library Station and end at Phan Fa Station. This Purple Line Section with bored tunnels, approximately 2.33 kilometers (km.) in length; approximately 25-35 meters under existing ground and the construction of 3 underground stations. The stations may be constructed by cut and cover and pipe roof procedure. Architectural works and Building Services within the stations together with other works. All more particularly described in the Employer's Requirements – Functional.

# Contract 3: Underground Civil Works (Phan Fa - Memorial Bridge Section)

Design and Construction of underground structure starting from the outer edge of Phan Fa Station and end at Memorial Bridge Underground Station, This Purple Line Section with bored tunnels, approximately 3.12 kilometers (km) in length; approximately 25-35 meters under existing ground and the construction of 2 underground stations (Sam Yot and Memorial Bridge Underground Station). The stations may be constructed by cut and cover and pipe roof procedure. Architectural works and Building Services within the stations together with other works. All more particularly described in the Employer's Requirements – Functional.

# Contract 4: Underground Civil Works (Memorial Bridge – Dao Khanong Section)

Design and Construction of underground structure starting from the outer edge of Memorial Bridge Station and end at the edge of transition structure. This Purple Line Section with bored tunnels, approximately 3.97 kilometers (km.) in length; approximately 25-35 meters under existing ground and the construction of 2 underground stations (Wong Wian Yai and Samre Underground Station). The cut and cover tunnels and transition structure are also included in this sub-section. Architectural works and Building Services within the stations together with other works. All more particularly described in the Employer's Requirements – Functional.

# Contract 5: Elevated Civil Works (Dao Khanong to Khru Nai Section, Stabling Yard and Park & Ride Facilities)

Construction of Elevated Structure from transition structure near Dao Khanong Station to Khru Nal Station along Suk Sawad Road. This Purple Line Section consists of precast segmental box girder viaduct of approximately 9.34 kilometers (km.) in length and approximately 17 meters high above existing ground, with the construction of 7 elevated stations. Architectural works and Building Services within the stations and other works as defined in the Tender Documents.

Construction of Stabling Yard. The works consist of the construction of train stabling situated on platform which construct at Kanchanapisek Road.

Park & Ride Facilities. The works consist of the construction of two numbers of Park & Ride facilities constructs near Bang Pakok Station and two numbers of Park & Ride Building near Rat Burana Station.

## Contract 6: Trackwork

Design and Construction of trackwork along the mainline and Stabling Yard constructed by Contract 1, Contract 2, Contract 3, Contract 4, and Contract 5. The work includes the provision of trackwork, points and crossings, conductor rall power collector and second pour concrete plinths or slabs. The emergency walkway in underground section is also included in this Contract.





## Contract 7: M&E Works

Design, supply, installation, and testing of the M&E Systems and other related systems, including rolling stocks, whereby the M&E Systems supplied must be compatible with those of the existing MRT Purple Line Project. M&E Systems to be supplied include Signaling Systems, Power Supply Systems, SCADA System, Communication Systems, Automatic Fare Collection System, and Graphic Platform Screen Door System and Signage System. (Not included in this tender.)
